## **Pump Station Rental Expenses**

The Village Board discussed how to effectively meet additional overhead costs (aside from the subsidy received from NYC) to cover the electric and fuel costs incurred by the new tenants renting the pump station building. Benjamin Fenton suggested that the additional \$1,000.00 be taken from the Mayor & Village Trustee's salaries at \$200.00 a piece. David Morell, Todd Pascarella and Benjamin Fenton were not opposed to contributing part of their salaries. Village Trustee Harriet L. Grossman was opposed and Trustee Fred Woller was not present.
