Village of Fleischmanns Board Meeting July 9, 2012

The Village of Fleischmanns Board of Trustees held their regular Village Board meeting on Monday, July 9, 2012 at 5:00 p.m. Present were: Mayor Todd Pascarella, Harriet L. Grossman, and Kathleen Rostad Miles. Deputy Mayor Benjamin Fenton was absent and Village Trustee Fred Woller was absent.

Mark Birman

Mark Birman and his attorney, Dennis Metnick, approached the Village Board for an arrangement for Mr. Birman to purchase, and/or use of the Village parking lot directly across from 1625 Main Street. Mr. Birman would like to buy the parking lot in order to supply adequate parking for his establishment. Different options were discussed such as the selling the property to Mr. Birman, or possibly and easement with right of usage wherein the Village would keep ownership, leasing, etc. The Village Board suggested that Dennis Metnick, Esq. submit a proposal to the Village Board for review. The Village needs to maintain physical control and use of the property.

Mark Project, Inc./Peggy Ellsworth

Peggy Ellsworth advised Mark doesn't have money right now to fix the movie theatre, and there is no insurance right now. After a report on the inspection of the building, we can prioritize our approach. Meanwhile, Mark is filing a consolidated funding application for rural revitalization program just for the front portion of the building, which would entail the renovating of the upstairs. Peggy Ellsworth stated she would like to target middle income seniors for the ideal location. For the downstairs we can look towards two storefronts and restoration of the lobby as part of this proposal. This afternoon there was a long term recovery planning meeting. There is money in place for some specialized planning for the adaptive use or re-use of the rest of the theatre. Peggy advised the Village could put together a steering committee or action based committee & an advisory committee, a subset of that. Peggy presented a list of those who might possibly be on the committee; Paula DeSimone (Fleischmanns Resident), Justin Kolb (Festival of the Voice, Jim DePaiva (Theater Experience), Bud Sife (Main Street Resident), Colin Young (Fleischmanns Resident) Ezra Birnbaum (Fleischmanns First), Larry Reilly (Village Planning/Fleischmanns First), Patti Dell and Stuart (Dance and Theater Experience), Rob Alverson (Fleischmanns First/Main Street Resident). Representation can come from the Village Board, Belleayre Music Festival, Roxbury Arts Group, West Kortright Center, UPAC, Fleischmanns Fire Department, Fleischmanns Seniors, and the Fleischmanns Business Community. The steering committee should be limited to 15-20 people. Or, there could be an action oriented group and an advisory council. The lease for the theatre is very close to being agreed on; however, until there are funds for immediate repairs, the theatre cannot be put in use.

Peggy advised that they were wrapping up their Community Development Block Grant; there was an excess of 7 or 8 owner occupied homes which received some assistance for health & safety & for energy efficiency projects in their homes in Fleischmanns. It has been a very successful program and we may reapply next year because there may be a waiting list by then.

We also have the rental rehab program which is active now & Fleischmanns is eligible for which is to rehab rental units up to \$25,000.00 per unit in facilities that have two units or more of rental apartments.

Peggy Ellsworth answered all questions from the Board and the public.

Mayor Pascarella advised that Delaware Engineering is working on the sidewalks which need go out to bid as soon as possible.

Further discussion was held by the Village Board as to the delinquent rental money owed to the Village of Fleischmanns by Fleischmanns Pizza Co. and the issue of the equipment which still remains at the location. Village Trustee Kathleen Rostad Miles advised she was willing to go into the former pizza store to remove the Christmas decorations & spruce up the window.

East Branch Stream Management Recreational Access Grant Presentation By Martie Gailes & Aaron Bennett

Martie Gailes reminded everyone that Delaware County Soil and Water had a grant for a study as to how we can improve recreational access to the east branch & Aaron Bennett is the consultant hired and the discovery center is the lead agency. The project was to figure out what is existing and what potential access points could be and identify those areas. Phase 2 would be to go back to the Delaware County Soil & Water Conservation District through the stream management implementation grants & apply for funding to implement things that came to the surface in Fleischmanns, Middletown, Margaretville and Roxbury. Aaron directed everyone to access the website called the Eastbranchaccess.com which contains relevant documents, meeting information, up-dated draft maps of the access points, or potential access points, etc. Access points were identified along the Bushkill and the Emory Brook.

Delaware Engineering/John Brust

John Brust advised that Delaware Engineering is continuing to work with FEMA, SEMO & Larry Reilly, doing appeals for the FEMA costs estimates they were given. Delaware Engineering is also working Graden Dutcher of Delaware County Soil and Water Conservation on an alignment for the wall at the park and we need to get an official blue book.

As to the Water Project, the Village has approximately \$250,000.00 left in grant money. Bids were put out for water mains for Halcott and for Switzerland. Four responses were received; one from Vacri Construction, Simpson, and Grant Street, and the lowest bidder was Hubbell Bros.
